WHEREAS, the Comptroller believes that the protection of the depositors, other customers and shareholders of the Bank as well as its safe and sound operation now require that the Comptroller and the Bank enter into a Consent Order, the contents of which shall supersede the Formal Agreement dated January 15, 2009; and

WHEREAS, the Bank and the Comptroller entered into the aforementioned Consent Order on April 15, 2010;

NOW, THEREFORE, the Comptroller directs that the Formal Agreement dated January 15, 2009, be, and hereby is, TERMINATED.
