WHEREAS, in an effort to protect the depositors, other customers and shareholders of AmFirst Bank, N.A., McCook, Nebraska (“Bank”), and to ensure the Bank’s operation in a safe and sound manner and in accordance with all applicable laws, rules and regulations, the Bank and the Comptroller of the Currency of the United States of America (“Comptroller”), entered into a Formal Agreement, dated December 15, 2010; and

WHEREAS, the Comptroller believes that the protection of the depositors, other customers and shareholders of the Bank as well as the Bank’s operation in accordance with all applicable laws, rules and regulations, do not require the continued existence of said Formal Agreement;

NOW, THEREFORE, the Comptroller directs that the Formal Agreement, dated December 15, 2010, between the Bank and the Comptroller be, and hereby is, TERMINATED.
