Introduction

Insurance Regulation 563.17-1a, "Appraisal Policies and Practices of Insured Institutions," permits the preparation of appraisals of non-residential properties on form reports approved by the Board and completed in accordance with the applicable instructional booklet.

A Commercial/Industrial appraisal report form was approved by the Board on March 30, 1988. That form was subject to change based on comments received during a test period that ended December 31, 1988. The form is now reissued in a revised version that reflects suggested changes submitted by commenters. A sample copy of the new form, as printed in the fast index from the applicable instruction manual, is attached.

The form and manual are the product of a joint effort of professional and trade organizations including the Appraisal Foundation, a non-profit educational organization, which is responsible for initial marketing of the form. Copies of the form and instruction manual may now be obtained by contacting The Appraisal Foundation located at 1029 Vermont Avenue N.W., Suite 900, Washington, D.C. 20005, 202-347-7722. Copies should be available from a variety of vendors in the near future. In addition, software will eventually be available that will allow for a laser-printed form.

Comments During Test Period

The content of both the form and instruction manual are again subject to modification based on comments received during a test period. The test period commences with the distribution of this memorandum and ends December 31, 1989. Comments and suggestions from all users are encouraged. In order to effect changes prior to the expiration date, all comments must be received by September 30, 1989. Comments
