Wholesale Payment Systems Booklet

The Office of Thrift Supervision, along with the other federal banking agencies, today issued updated guidance for examiners, financial institutions, and technology service providers on financial institutions' information technology (IT) operations and wholesale payment systems activities. The *Operations Booklet* and the *Wholesale Payment Systems Booklet* are the last in a series of twelve booklets issued through the Federal Financial Institutions Examination Council (FFIEC) that have updated and replaced the 1996 FFIEC Information Systems Examination Handbook.

The evolving role that technology plays in supporting financial business functions has become increasingly complex. IT operations—once contained in a closed environment within a data center—have become more dynamic and include distributed systems, integrated applications, telecommunications options, Internet connectivity, and an array of computer operating platforms. And as the complexity of operations technology has grown, the risks inherent in your thrift's IT operations have also grown. The *Operations Booklet* provides guidance to examiners and thrift institutions regarding the risk management of IT operations, and will be used by OTS examiners in their evaluations of your management and operational controls and those of your technology service providers.

Thrift institutions, through their support of a variety of financial markets, play an important role in wholesale payment systems. However, they face increasing challenges to meet requirements for resilience and reliability, while continuing to foster innovative solutions to meet expanding global payment processing demands. These challenges pose increased risks to your thrift and require greater diligence on the part of your management and board of directors to ensure the confidentiality, integrity and availability of your customers' information. The *Wholesale Payment Systems Booklet* provides guidance and procedures that OTS examiners will use to evaluate your management of the risks inherent in your wholesale payment systems and in those of your technology service providers.

These two booklets represent the last in the present series of updates to the 1996 FFIEC Information Systems Examination Handbook (1996 Handbook). The updates have been issued in separate booklets that replace all chapters of the 1996 Handbook and which now comprise the new FFIEC Information Technology Examination Handbook. With the release of these last two booklets, the 1996 Handbook is now completely retired. Chapters 1 through 23 of the 1996 Handbook were rescinded with the issuance of the various booklets. Chapter 24 and chapters 26 through 30 contained laws, regulations, and guidance related to the topic of IT issued by OTS and other FFIEC agencies. With the issuance of the new FFIEC Information Technology Examination Handbook, several Supervisory Policies (SP) found in Chapter 25 of the 1996 Handbook are rescinded. These are:
