ORDER TERMINATING
ORDER TO CEASE AND DESIST FOR AFFIRMATIVE RELIEF,
OTS Order No. MWR 05-2, dated February 25, 2005;
AMENDED ORDER, OTS Order No. WN-10-03, dated February 19, 2010; and
AMENDED ORDER, OTS Order No. WN-11-005, dated February 15, 2011

WHEREAS, on February 25, 2005, the Office of Thrift Supervision (OTS) issued an Order to Cease and Desist for Affirmative Relief, with the accompanying Stipulation and Consent to Issuance of an Order to Cease and Desist for Affirmative Relief, MWR-05-2 (Order), against Chicago Title Insurance Company (Chicago Title), as Settlement Agent for Allied Houston Bank, Houston, Texas, OTS Docket No. 08135; Ohio Savings Bank, Cleveland, Ohio, OTS Docket No. 04072; and Guaranty Federal Savings Bank, Dallas, Texas, OTS Docket No. 08534; and

WHEREAS, on February 19, 2010, the OTS amended the Order, by Amended Order, WN-10-013 (First Amended Order), which extended the termination date of the Order; and

WHEREAS, on February 15, 2011, the OTS further amended the Order, by Amended Order, WN-11-005 (Second Amended Order), which further extended the termination date of the Order; and

WHEREAS, the OTS is authorized by Section 8 of the Federal Deposit Insurance Act, 12 U.S.C. § 1818, to issue enforcement orders, including orders to cease and desist, and such orders remain effective and enforceable, except to the extent that such orders are modified or terminated by action of the OTS; and

WHEREAS, the OTS Regional Director for the Western Region (Regional Director) has authority to terminate the Order and any amended orders; and

WHEREAS, the OTS, acting by and through the Regional Director, has determined that Chicago Title has complied with the terms of the Order, and that it is appropriate to terminate the Order, the First Amended Order, and the Second Amended Order.

NOW, THEREFORE, IT IS ORDERED that Order (MWR 05-2), First Amended Order (WN-10-03), and Second Amended Order (WN-11-005), are hereby terminated in their entirety as of the Effective Date on the first page of this Order.
